Clinical Laboratory

Autoimmune Testing Analyzers, Reagents, Consumables and Service

Expires March 31, 2025

This category includes analyzers that perform testing for autoimmune diseases. These tests aid in the diagnosis and management of autoimmune diseases and immunoglobulin E (IgE) allergic disorders.

Automated Microbial Identification and Susceptibility Analyzers, Reagents, Consumables and Service Expires October 31, 2024

This category includes automated instruments that identify microorganisms and determine the lowest concentration of antimicrobial agent that will inhibit growth in clinical cultures.

Blood Gas Analyzers, Reagents, Consumables and Service Expires April 30, 2027

This category includes benchtop analyzers used to monitor patients' acid-base balance and oxygen-carbon dioxide exchange, which provide the clinician with information to use in patient diagnosis and regulation of therapy.

Chemistry and Immunochemistry Analyzers, Reagents, Consumables and Service Expires March 31, 2025

This category includes clinical chemistry analyzers, immunoassay analyzers and integrated laboratory analyzers that perform both clinical chemistry and immunoassay testing.

Coagulation Analyzers, Reagents, Consumables and Service Expires July 31, 2024

This category includes products used to provide coagulation testing. Hemostasis testing is used to diagnose coagulation disorders and to monitor patients on anti-coagulant medicines.

Automated Blood Culture Analyzers, Reagents, Consumables and Service

Expires October 31, 2024

This category includes instruments designed for the rapid detection of bacterial and mycobacterial organisms growing in blood culture bottles.

Blood Bank Analyzers, Reagents, Consumables and Service Expires January 31, 2025

This category includes products that are used for automated and manual testing in the blood bank.

Blood Glucose Meters, Reagents, Consumables and Service Expires March 31, 2030

This category includes blood glucose handheld meter systems that are primarily used in acute care facilities to determine the approximate concentration of glucose in the blood. The system includes the meter and hardware/software needed to transmit the patient results with the electronic medical record (EMR), health information system (HIS) or laboratory information system (LIS).

Clinical Reference Laboratory Testing Services Expires September 30, 2026

This category includes accredited laboratories who perform testing on patient samples and provide a varied menu of laboratory procedures including routine tests with minimal complexity to esoteric tests with high complexity.

Digital Pathology Systems, Accessories and Service Expires May 31, 2025

Genetic Sequencing Expires January 31, 2026

This category includes instruments, reagents and/or consumables for sequencing the DNA or RNA to study genetic variation associated with diseases or other biological phenomena. This category also includes but is not limited to extraction kits, sample library and preparation materials, quality control, service and data analysis.

Histology and Cytology Products, Equipment and Service Expires January 31, 2029

This category includes products, equipment and service used in histology, cytology or morgue/autopsy to collect, prepare, fix, preserve and stain samples for evaluation.

Laboratory Equipment, Accessories and Services Expires March 31, 2027

Expires July 31, 2025

This category includes hematology analyzers, reagents, consumables and hematology analyzer services used to provide hematology testing. The primary focus of hematology testing is the diagnosis of disease related to the production of blood and/or its components.
